## **BLACK MEMBERS TRAINING**



## **BUILDING JUSTICE OUT OF CRISIS**

**Edinburgh World Justice Festival Report by Nahid Aslam** 



UNISON hosted the BUILDING JUSTICE OUT OF CRISIS event as part of the Edinburgh World Justice Festival on the 22nd May 2009. The event was chaired by Mike Kirby, Convenor, UNISON Scotland and it was well attended, with many UNISON members present. Speakers included the Secretary for State for International Development - Douglas Alexander MP, Allyson Pollock, Centre for International Public Health Policy, Edinburgh University and Benedict Southworth from the World Development Movement (WDM).

Alexander stated that the global financial system was important for the global poor. The World Bank was necessary for development. However Pollock reminded the audience that Britain's wealth was built on the back of slavery and imperialism, and the way that the World Bank worked to promote Trade Liberalisation in developing countries was nothing short of imperialism in another form. It did not protect countries or workers because of the unfair power relations embedded in its philosophy.

The question of 'Health for All' came up and we were informed that Health Facilities available in poorer countries were fragmented. Facilities provided by DFID were linked to trade rather than genuine need. Sanitation and nutrition are essentials, yet expensive medicines that benefit the West are what is promoted.

Southworth stated that trade was necessary to get people out of poverty. But the Market needed to be civilised and this was the task of the Left. The audience was asked 'What can we in the UK / Scotland do'? Fair Trade is the most advanced in the UK as compared to other EU countries. Could we be more forceful in pushing this idea on our EU partners? Also should we work to increase the Fair Trade product range?

The Event was informative, giving plenty of time for questions and answers. Many thanks to Matthew Crighton and his ID team for organising it.

## HAPPY BIRTHDAY AUNG SAN SUU KYI



More than 2,000 delegates at the UNISON national conference in Brighton donned masks of Burma pro-democracy leader Aung San Suu Kyi in protest at her continued detention by the Burmese military.

It was a show of solidarity and support for the National League for Democracy leader on the eve of her 64th birthday. During the masked protest, UNISON Vice-President, Angela Lynes, read out a message calling for Suu Kyi's immediate release and for the Burmese Government to end the "repression" of its people and respect human and labour rights.
