# Local Government Finance Settlement 2010-11

## Introduction

This briefing covers revenue funding allocations to local authorities for 2010-11.

All local authorities have now agreed to continue the council tax freeze, entitling them, like last year, to a share of £70m funding. Mr Swinney also confirmed that councils will be able to borrow £65.4 million to help spread equal pay back pay costs over a longer period. Councils will share £5 million for repairing roads following the severe cold weather.

The table overleaf has individual revenue allocations for each council, totalling nearly  $\pounds 10.7$  billion. It is compiled from Finance Circular 1/2010. www.scotland.gov.uk/Resource/Doc/91 9/0094629.pdf (They will also receive support for capital funding of more than  $\pounds 843$  million.)

The Scottish Parliament Information Centre Briefing on the settlement (www.scottish.parliament.uk/business/r esearch/briefings-10/SB10-12.pdf) says that overall adjusted revenue allocations in cash terms increase by 2.93% from  $\pounds$ 10.4 billion in 2009-10 to  $\pounds$ 10.7 billion in 2010-11. Perth & Kinross has the largest increase (5.19%) and Glasgow City has the lowest, at 1.65%.

In real terms, adjusted revenue allocations increase by 0.67%. Perth & Kinross goes up by 2.87%, while five councils, in real terms, receive a decreased allocation. They are: East Dunbartonshire (-0.07%), Edinburgh City (-0.42%), Glasgow City (-0.59%), Inverclyde (-0.20%) and Shetland Islands Council (-0.56%). Adjusted capital allocations decline by -4.56% in cash terms, and -6.6% in real terms.

Overall adjusted combined revenue and capital allocations increase by 0.07%, but ten councils will see their allocations decline: & Bute. Argyll East Dunbartonshire, Edinburgh, Fife. Midlothian, Glasgow, Inverclyde, Moray, North Ayrshire and Shetland Islands.

'Real terms' budgeting needs to be treated with some caution. This is based on a government assumption that inflation will be 1.5%. The government's preferred measure of inflation, the CPI, is already at 3.5% and the RPI is at 3.7%. This means that the cuts are likely to be much greater than the figures above would indicate for every council.

Councils face increasing pressures to meet Concordat, efficiency savings and other commitments, greater demands on services, decreased charges and fees income and changes with the ending of most ring fenced funding, plus the effects of the council tax freeze and reduced small business rates. Deeper cuts are predicted for coming years.

### UNISON's Stop the Cuts/Public Works campaign & analysis

UNISON Scotland's Public Works campaign was launched by the union's General Secretary Dave Prentis in Glagow on 6 February. He condemned macho political posturing on cuts and stressed the importance of public spending to economic recovery.

Figures from branches show that local government is facing more than £300 million of cuts and nearly 5,000 jobs will go through voluntary redundancies, early retirement etc. A major Stop the Cuts march and rally will take place in Glasgow on Saturday 10 April.

# Action for Branches

The scale of cuts proposed by most councils is significantly greater than the reduced allocations in this financial settlement, even allowing for other cost pressures. This may be partly explained by the part year impact of some cuts proposals. However, branches should look carefully at the claimed expenditure growth items, balances etc to be satisfied that they are justified in this financial climate. The guide to council finances in the cuts pack is a resource, together with support from your Regional Organiser.

Many branches are actively campaigning in defence of services and building links in their communities with service users. These campaigns should support the mobilisation of members and local community groups for the 10 April event.
