Million Voices for Change - Public Works

UNISON Scotland has launched its 'Public Works' campaign with the message that public service cuts will increase costs for ordinary families and will delay economic recovery. 'Public Works' is the Scottish arm of the union's 'Million Voices for Change' campaign.

UNISON has warned that the headlong rush to cut and privatise public services will lead to delays in coming out of recession It has produced a leaflet demonstrating the importance of public services to everyone's lives and pointing to the huge costs that would fall on people if public services were not available.

The 'A Day in the Life' leaflet follows an average woman through her day and points out our dependence on public services - from water and sewerage, through environmental health and refuse collection, to education and health care. Scottish Labour MSP's have been quick to add their support to the campaign, including shadow cabinet members, at an event in the Scottish Parliament during trade union week. The UNISON Scotland Labour Link Committee also met recently in Parliament to promote the campaign. They were joined by the Convenor of the UNISON Group of MSPs, Karen Gillon MSP to consider how best to build these ideas into the Scottish Labour manifesto for 2011.

Scottish Parliament Candidate Selection

The Boundary Commission for Scotland has now confirmed the revised constituency boundaries for the Scottish elections in 2011. The list areas are still to be finalised. As a consequence the Scottish Labour Party has asked CLPs to begin the process to re-select sitting MSPs and select candidates for those seats with no sitting Labour MSP. All re-selections should be completed by Christmas.

UNISON is affiliated to all CLPs in Scotland but they are organised on the Westminster constituencies. The rules therefore provide that UNISON is entitled to make an affirmative nomination for every branch that is affiliated to any CLP that covers the Scottish Parliament constituency, providing that the branch has members residing within that Scottish Parliament constituency.

CLPs should send nomination papers to UNISON House who will forward the documentation to the relevant UNISON Branch Labour Link Officers. They should consult and advise UNISON House if they do not wish to confirm the sitting MSP or indicate if they wish to nominate a particular candidate if there is an open selection. The detailed process will be explained in the covering letter.

Strengthening Local Parties

A key recommendation of the Task Group established after the 2007 elections was to review what type of local party organisation is needed to maximise political debate and campaigning at local level. The basic Scottish Labour Party structure has remained largely unchanged for a generation and arguably is no longer appropriate given the political, social and technological changes in recent years.

A consultation pack has been issued seeking views on branch structures and how we can better co-ordinate the Westminster, European, Scottish Parliament and local council structures that all operate on different constituencies.
