



BRANCH SECRETARIES BRIEFING FOR SCOTTISH LOCAL GOVERNMENT BRANCHES

Call for Action

Branches and members will have by now received the results of the ballot over the SJC pay offer. As a result of the 'yes' vote, the Industrial Action Committee has given the 'go ahead' for all-out strike action on **20 August 2008.** A Call for Action letter will be direct mailed to every member on or about 8 August encouraging them to take action. Notice of Action letters to the employers will be sent out also on the 8th August.

Taking strike action is never an easy decision for members of this union. We prefer to do what we do best – provide quality services for the public. But having won a 'yes' vote for action, it is now up to the union at all levels to deliver on that action and make the employers come back to the negotiating table.

And that means all of us. We need stewards and reps who are in daily contact with members to get the maximum possible turnout. Members who are already facing steep price rises in mortgage, food, gas and electricity might wonder whether losing pay in a strike is worth it. We have to convince them that it's the strength of turn-out which will make the strike successful.

A large turn-out will send a clear message to the employers that they must improve their offer and show members the respect they deserve.

UNISON will be putting all its resources into making sure that our members on SJC pay and conditions make this action a huge success and get the employers back to the negotiating table. Please support your union – together we can make a difference.

Special Meeting for Branch Secretaries

Following the very successful ballot for industrial action there will be a one day strike on **Wednesday 20 August.** More information will be provided but
