## WORKER'S MEMORIAL DAY

**Saturday, 28<sup>th</sup> April** is **Workers' Memorial Day**. The main focus in Scotland is a wreath laying ceremony in George Square in Glasgow at 1.00PM on Saturday. The Scottish Region, and Glasgow City Branch have ordered wreaths from the STUC. 14 Scottish councils have so far agreed to fly their flags at half mast and now over 20 countries have declared it a national holiday.

UNISON is launching a campaign on Friday, 27th April asking the UK government to give official recognition to 28 April, Workers' Memorial Day. to be recognised as a national day of remembrance for those killed or injured by their work.

To mark the launch of the campaign, there will be a short meeting at the front of each of the UNISON offices in Scotland at 12.00 on Friday, 27 April, which will include a UNISON-wide minute's silence.

### FAMILES AGAINST CORPORATE KILLERS (FACK)

At a fringe meeting at the STUC in April Families against Corporate Killers (FACK) was launched, and highlighted the number of people killed in work related incidents each year, condemned by STUC General Secretary, Graham Smith, as "unacceptable". The group aims to campaign for an end to work-related deaths, as well as support for bereaved families .

They are also campaigning for tighter legislation to hold bosses of companies found to be guilty of negligence leading to injuries or deaths accountable for the killings. The Corporate Manslaughter Bill has become stuck in the House of Lords over the issue of deaths in custody. The TUC is urging all union reps and campaigners to back a proposal for more serious safety penalties on dangerous employers.
