Welfare AGM and Seminar Success

The seminar held at Croyde Bay started on the Thursday afternoon with an introduction by the Chair Sue Highton and Head of 'there for you' Julie Grant.

Day one

The facilitator of the seminar was Amanda Stott, commencing with **Setting up for Success** with Amanda putting paper balloons on delegates tables so they could write down their ideas to be then put on large whiteboards showing all regional delegates what UNISON Branch Welfare Officers can offer or what they need to help them to do their role and also what the Regions achieved in 2013 and what they wanted to achieve in 2014.

The next session was **Training and Support** where Amanda and 'there for you' Caseworker Janine logged into the UNISON 'there for you' website and all the delegates at the seminar answered examples of the online training questions - and we all passed.

The last session that afternoon was split into Regional groups to discuss **Regional Objectives** and what the Committee does with their Link Trustee. The Scottish delegates spent some time introducing themselves as we had new attendees with us. Maureen Le Marinel, our Link Trustee and President of UNISON explained the role of the Link Trustee and how the Board of Trustees is formed. We also discussed the role of the Committee and the importance that Branch Welfare Officers feed into the Committee so we can support them and provide valuable information and speakers at our seminar in November this year (see page 3).

Day two

We continued through more of the online training in mixed Regional groups and had excellent **Guest Speakers** then join us from Charis Grants; The Trussell Trust; London Credit Union and UNISON's own welfare



reforms team. The presentations are available and have been sent out to all Branch Welfare Officers by email (see below).

Day three

The AGM started with Sue Highton in the Chair and she welcomed everyone to our 2014 Annual General Meeting.

The Chair informed the delegates of the sad passing away of two active members of our welfare charity from Scotland, Les Chalmers and Tom Clark. The AGM held a minutes silence in their memory.

The Chair also announced the retirement of Karen Smith, UNISON Welfare - 'there for you' Administrator and she was presented with flowers and a collection from delegates who had contributed during the seminar.

There was no election for Link Trustees this year as 6 people put themselves forward unopposed.

We went through the financial report presented by June Poole, Vice Chair of the Board of Trustees, where she was able to take any questions from the delegates.

There were two motions this year with the first being to produce a simplified version of the criteria for welfare assistance to be distributed with welfare application forms sent to members. This was proposed by West Midlands Region and supported by The Board of Trustees. This was won in the delegate's ballot and subsequent vote.

The second was from the Scottish Region and this was to note that all Branch Welfare Officers in principal should be able to attend the AGM, but given the practicalities, a limit of no less than 20 delegates from each Region should be allowed to attend. This was opposed by the Board of Trustees and after a lively debate with Adanna Brown - Chair of the Scottish Welfare Committee, Lila Sneddon - Vice Chair of the Scottish Welfare Committee, Liz Rankin - Scottish Committee member and Michael Gettins - a new Branch Welfare Officer from Scotland, all spoke in support of the motion. The motion was

moved to a vote in a ballot of delegates and was unanimously supported and won in favor of the motion.

As time was moving on, the AGM finished with a vote of thanks to the Chair.

Finally, let's not forget the **Social Activities** arranged for us at Croyde Bay from special guest Elvis to other live bands and entertainment to allow delegates to wind down after all their hard work during the day's events.

Branch Welfare Officer Training 25th to 27th April 2014

Another successful training event was held this year for all Branch Officers in Glasgow's Jury's Inn which included Branch Welfare Officers training facilitated by our committees co-opted member and Link Trustee Andy Douglas from Stirling Local Government Branch.

Andy said 'First of all, I would like to thank Nancy Kelly and the Learning and Organising Committee for working with our Committee to include Welfare in the Branch Officers weekend. Prior to this, Scottish Branch Welfare Officers had to go to Leeds and Manchester to get accredited.

This year twelve Welfare Officers attended. The course was over two and a half days plus the e-learning part, which should be completed prior to the course proper. Welfare Officers brushed up on interview

techniques. They also heard about other agencies that can assist with their role as Welfare Officers. They also went over successful form filling, a very important part of things getting accepted and processed quicker by UNISON headquarters in London. Feedback was very positive and the group also made some lasting friendships. A very worthwhile and successful event'.

It is also part of our commitment to provide ongoing training and support and follows on from the introductory training completed in April 2014. Therefore, additional training has been developed by the casework team from UNISON headquarters.

On the day the casework team will deliver 'Making the Case' – a highly interactive training session that will illustrate how to ensure that you get the most effective and swiftest help for your members. You will also have the opportunity to meet other Branch Welfare Officers to share best practices and experiences as well as discuss actual cases.

The training will be held on Thursday 18th September 2014 at the UNISON Centre in London. Scottish Branch Welfare Officers should have all been informed by email of this event, but if not, please get in touch as places are limited.

Seminar 2013

Last year's seminar was held on the 9th and 10th November which included five guest speakers and two workshops on budgeting and presentation skills. Statistics within the UK

The total number of applications received for School Uniform Grants was 579 compared with 998 in 2012 and 780 in 2011. This shows a decrease of 42% on 2012 and it can only be assumed that the scheme was not publicised sufficiently by branches.



Success stories, statistics and milestones achieved

Winter Fuel Grant 2014

Across Scotland, UNISON 'there for you' received 141 applications. The committee must congratulate South Lanarkshire Local Government branch in achieving 40 successful grants and the efforts they made in promoting this vital service for our members. It will soon be time again this winter where our members suffer from fuel poverty and UNISON 'there for you' hopes to once again allow members to apply for winter fuel grants in 2015. Once we hear any developments in this area of financial assistance, we will let you know what you can do to encourage your members to apply taking a lead from South Lanarkshire.

School Uniform Grant 2013

Across the UK, 664 children were assisted with a grant for school uniforms. All applications were fully completed and grant payments were made totaling £26,560. Recorded data shows that the majority of applicants continue to come from the Health and Local Government service groups with a combined total of 87%. In Scotland, a total of 94 applications were received and we ask that Branch Welfare Officers across Scotland continue to publicise this important service for our members of which one said "I am a single parent, and find it a struggle keeping up with my growing children, they grow out of things so quickly and they won't wear old shoes or trousers for worrying about being teased at school. I also have my eldest son living at home who is a full-time student". Whilst the survey of responses show that the majority of members use supermarket clothing for value, 47% of members use Clarks for school shoes. Almost 75% of

members were forced to use specialist suppliers for certain items of school uniform.

Applications for 2014 closed on 11th July and we will update you on the results of the latest campaign.

Beat the Payday loans scandal

As Branch Welfare Officers, we are all too familiar with the impact of our members taking out loans from TV advertised money lenders who charge exorbitant interest rates. UNISON members can now access low-interest loans and a range of savings products through our ever expanding partnership with Credit Unions across Scotland and the UK. Credit Unions offer an ethical alternative lending solution tailored to benefit our member's circumstances and to encourage saving. Unlike mainstream banks, Credit Unions are more flexible and will look at individual circumstances, affordability and whether there is a payroll deduction scheme in place with your employer.



To become a member you must meet the membership criteria often referred to as the common bond. The overall majority of our members will meet these criteria and we encourage all Branch Welfare Officers to promote their services and steer our members away from Payday loan and other scrupulous alternatives. Just in – Payday lending action plan for Scotland

The Scottish Government has announced tighter regulations and stricter planning procedures to help limit the numbers of new payday lenders on Scotland's high streets.

The measures which are designed to minimise the presence of payday lenders in communities are set out in a new 12 point [Scottish Government action plan](#) launched by Local Government Minister Derek Mackay MSP.

The plan is a result of Scotland's first Payday Lending Summit earlier this year and based on feedback from local authorities, advice services, welfare organisations and credit union representatives who attended.

Launching the plan on a visit to the Glasgow Central Citizens Advice Bureau, Mr Mackay said: "This action plan reinforces our commitment to addressing the problems associated with payday lending and sets out a number of actions that we will undertake across a range of policy areas. Through legislation we will remove some of the exemptions from planning control on premises that sell pay day loans. This will allow planning authorities to implement policies addressing future clustering and over-provision of such activities.

"We're making conditions tougher for payday lenders by excluding them from small business bonus schemes and working with the Financial Conduct Authority to tighten up regulations."

The Scottish Parliament passed the Bankruptcy and Debt Advice (Scotland) Bill with cross-party support in March of this year. The Bill included the creation of a Financial Health Service (FHS), and the new Action Plan includes a commitment to "explore how to further promote credit unions as potential alternative lenders as a key part of the FHS."
